

**INTERLAKE SCHOOL DIVISION  
BY-LAW NO. 4-2020**

**TRUSTEES' INDEMNITIES**

BEING A BY-LAW of the Interlake School Division providing for the payment of indemnities, mileage, and expenses to members of the Board of Trustees, pursuant to Section 56, Subsection (1), (2) and (3) of the Public Schools Act.

The Trustees of the Interlake School Division, at a meeting called and held for the purpose, do hereby enact as follows:

1. **INDEMNITIES:**

That effective February 1-2020, the following indemnities be paid:

- i) Ten thousand and four hundred and ninety seven dollars and sixty five cents (\$10,497.65) per annum for each Trustee;
- ii) An additional two thousand and nine hundred and sixteen dollars and twenty-four cents (\$2,916.24) per annum for the Board Chairperson.
- iii) An additional one thousand and one hundred and sixty six dollars and thirty eight cents (\$1,166.38) per annum for the Board Vice-Chairperson and the Chair of Negotiations.

2. That a Trustee be reimbursed for all expenses necessarily incurred while attending any convention, seminar or while carry out other duties assigned or approved by the Board as follows:

(A) **CONVENTIONS and/or SEMINAR EXPENSES:**

- i) Air Fare or travel costs and all applicable registration fees;
- ii) Indemnity at a flat rate of \$150.00 for a full day.
- iii) Daily meal expenses where the conference does not provide meals shall be as follows:
  - Within Manitoba \$35.00 per day
  - Out of Province \$75.00 per day (paid in US funds if outside Canada)

(B) **COMMITTEE MEETINGS OR BOARD APPROVED BUSINESS:**

- i) Be reimbursed at a rate of \$65.00 for the first four hours for each approved Special Meeting or Committee Meeting;
- ii) Be reimbursed at a rate of \$150.00 for more than four hours for each approved Special Meeting or Committee Meeting;
- iii) Committee Meetings of less than 2 hours, held prior to a regular Board Meeting will be paid at a rate of \$30.00;
- iv) Be reimbursed at a hourly rate of \$20.00 for approved school/division business other than approved committee meetings.

(C) **TRAVEL ALLOWANCE:**

- i) A vehicle expense allowance as per the Divisional rate of forty cents (\$0.40) per kilometer.

3. That this By-Law supercedes all previous By-Laws pertaining to indemnities, mileage, and expenses payable to Trustees of the Interlake School Division and By-Law 4-2019 is hereby repealed.
