# **SUPERINTENDENTS' DEPARTMENT REPORT:**

THE BOARD OF TRUSTEES WAS PROVIDED WITH A LISTING OF STAFF CHANGES THAT HAVE BEEN APPROVED BY THE SUPERINTENDENT AS PER SECTION 52 OF THE PUBLIC SCHOOLS ACT AS OF MAY  $8^{\text{TH}}$ , 2023.

THE BOARD OF TRUSTEES WAS INFORMED THAT MANITOBA EDUCATION PROVIDES GRADUATION RATES FOR ALL SCHOOL DIVISIONS ON A YEARLY BASIS. GRADUATION DATA FROM JUNE OF 2022 WAS RECENTLY RELEASED VIA THE MANITOBA EDUCATION WEBSITE. INTERLAKE SCHOOL DIVISION IS ONE OF ONLY FOUR PUBLIC SCHOOL DIVISIONS WITH A 4-YEAR GRADUATION RATE ABOVE 90% WITH A SUCCESS RATE OF 92.0%.

THE BOARD OF TRUSTEES WAS PROVIDED WITH THE FINAL 2023-2024 SCHOOL YEAR CALENDAR. THE CALENDAR INCLUDES FIVE SCHOOL PLANNING DAYS AND FIVE PROFESSIONAL LEARNING DAYS. NEW FACTORS IN THE 2023-2024 CALENDAR INCLUDE:

- NATIONAL DAY FOR TRUTH AND RECONCILIATION AND REMEMBRANCE DAY FALL ON THE WEEKEND, AND GOOD FRIDAY FALLS ON SPRING BREAK
- TUESDAY, OCTOBER 3<sup>RD</sup> IS AN INSERVICE DAY ON THE FIXED-DATE PROVINCIAL ELECTION DAY
- A MOVE AWAY FROM EARLY DISMISSAL DAYS
