DELEGATIONS/PRESENTATIONS:

SAFETY OFFICER'S REPORT:

Robyn Lowe, Safety Officer, appeared before the Board to provide an overview of Workplace Safety and Health at Interlake School Division. Responsibilities of the position include being a resource to stakeholders in the Division, responding to improvement and stop work orders, following up on incident reports, preparing the annual report on workplace violence, performing site inspections and audits, developing safe work procedures, training, indoor air quality monitoring and audiometric testing.

Upcoming projects include implementing the work alone procedure, radon testing, expanding asbestos awareness to employee orientation and the upcoming divisional workplace safety and health committee structure.

MAINTENANCE SUPERVISOR'S REPORT:

Anthony Cornwell, Maintenance Supervisor, presented the Maintenance Report to the Board of Trustees.

An update on the Collège Stonewall Collegiate boiler project was provided,

The Board of Trustees was provided with an overview of planned summer projects:

- Balmoral School new garage for storage
- École Stonewall Centennial School new office flooring, accessible culinary arts kitchen
- Collège Stonewall Collegiate exterior painting of building front and section from 1961
- Stony Mountain School new classroom cupboards
- Teulon Elementary School new PA system for the entire school, electrical upgrade and new cubbies
- Teulon Collegiate new countertops in the culinary arts room
- Warren Collegiate fire alarm upgrade
- Warren Elementary School new PA system for the entire school
- École R.W. Bobby Bend School install new flooring

The Board of Trustees was provided with the planned tradespersons' summer work:

<u>Carpenter</u>: Build new cubbies for Teulon Elementary School, remove countertop at Teulon Collegiate and remove cupboards at Stony Mountain School.

<u>Electrician</u>: Install new electrical panel upgrade at Warren Elementary School, install cameras at Warren Collegiate, Collège Stonewall Collegiate and École R.W. Bobby Bend School, and upgrade lighting at Teulon Collegiate.

<u>Plumber</u>: Install new classroom sinks at École R.W. Bobby Bend School, new sinks in Teulon Collegiate's culinary arts room, and eyewash station installs at multiple locations.

The Board of Trustees was informed that teh Interlake School Division has hired 5 Green Team members for the Maintenance Department. These students will cut grass across the Division, perform grounds maintenance and assist tradespeople.

The Board of Trustees was informed that the installation of high-efficiency boilers in our schools (École Stonewall Centennial School, Teulon Elementary School, Stony Mountain School, Collège Stonewall Collegiate) and recent envelope projects at Teulon Elementary School and École R.W. Bobby Bend School have resulted in cost savings in electricity and natural gas.

PARENT DELEGATION:

At 8:15 pm parent delegation Dana Scrivens and Angela Grandmont, supported by Starting Blocks Executive Director Nikki Kibsey, appeared before the Board of Trustees to present on school age care and programming in Stonewall. Information was shared on the current number of children requiring before or after-school care, the difficulties in finding childcare and the different types of school age programming offered around Manitoba. Starting Blocks Child Care is at capacity and cannot meet the current need for school age childcare. The request to the Board was to commit to participate in collaborative solutions for before-and-after school care, alongside other stakeholders.
