STUDENT SERVICES AND SCHOOL SOCIAL WORKERS PRESENTATION:

School Social Workers Vicky Brzuskiewicz, Jocelyn Mitchell and Jocelyn McMurray, and Student Services Administrator Michelle Procter, appeared before the Board to highlight how they are meeting the needs of divisional students, families and schools. Initiatives include organizing upcoming optional professional learning opportunities for educational assistants and child/youth support workers and facilitation of professional Learning Network 1: Regulation, and Learning Network 2: Presence and Engagement. The School Social Worker role is becoming more proactive, allowing for Tier 1 and 2 supports.
